1. I would appreciate a named contact.
2. You appear not to have read the LIEN CONTRACT or understood it.

*Therefore, I propose to simplify my case.*

1. Approximately 1 year prior to committal hearing [14.1.2013] a commercial lien notarial instrument was issued upon Pannone Partners Limited which contained questions that needed rebuttal, failing which financial penalties would apply.
