

Dear Alastair: Pitblado

We lay before you allegations of FRAUD, in the racketeering of Public Trustee & the Court of Protection.

Biography

Public Trustee

The Public Trustee administers trusts and estates where he has accepted appointment to do so.

He acts as:

- executor and administrator of the estates of the deceased
- trustee of trusts in the interests of vulnerable individuals or disabled people
- where there are differences between executors, trustees or beneficiaries

The Public Trustee also deals with the recording of applications for notice to quit under the Law of Property (Miscellaneous Provisions) Act 1994.
