



THE FAMILY COURT IS FRAUD:

Traditionally, the marriage vows are as follows:- "Dearly beloved, we are gathered together here in the sight of God, and in the face of this congregation, to join together this Man and this Woman in holy matrimony. If anyone has any reason why these two shall not be united in the bonds of matrimony, speak now or forever hold your peace. [Name], do you take [Name] to be your wedded [husband/wife] to live together in marriage. Do you promise to love, comfort, honor and keep [him/her] For better or worse, for richer or poorer, in sickness and in health. And forsaking all others, be faithful only to [him/her] so long as you both shall live?"

Once the vows are taken then the clergy will recite Matthew 19:6, "Therefore, what God has joined together, let no man put asunder - With the power vested in me, I pronounce you husband and wife. You may kiss the bride".

FRAUDULENT FAMILY COURT JUDGMENTS:

"But why judgest thou thy brother? Or again, why settest thou at naught thy brother? Let us therefore judge one another no more" (Romans 14). "No Freeman shall be dispossessed, or in any manner destroyed, unless by the lawful judgment of his own equals indeed the law of the land" (Magna Carta 1215). Magna Carta is entrenched Constitutional and **COMMON LAW** in Australia. The **RIGHT** to **TRIAL BY JURY** is inalienable, ie; it cannot be taken away and it cannot be given away. Unless both parties to any action in any Court sign a **MEMORANDUM OF CONSENT** to be without a **JURY**, no Court has **JURISDICTION** to proceed summarily, ie: without a **JURY**. "That the awards, doings and proceedings, to the prejudice of your people in any of the premises (ie: Magna Carta), shall not be drawn into consequence or example" (Petition of Right 1627), ie: they are illegal and void.

THE FAMILY COURT is a CORPORATION (ABN 63 684 208 971) and its JUDGMENTS are made SUMMARILY. Any Judgments made by the FAMILY COURT are illegal and void, and any actions taken by the Sheriffs under such Court Orders is **TRESPASS**.

DEMOCRACY IS THE RULE OF COMMON LAW:

"**COMMON LAW** doth control Acts of Parliament (ie: **STATUTE LAW**) and adjudges them when against common right to be void" (Lord Edward Coke).

COMMON LAW is the LAW of the PEOPLE, by the PEOPLE and for the PEOPLE. It is made by the congregations of twelve Freemen as **JURORS**, who ask "**So help me God**" for them to administer **JUSTICE** and **JUSTICE** is "the protection of rights and the punishment of wrongs", and "In a civilized society, the purpose of a court is the vindication of men's rights and the enforcement of just causes" (Lord Denning). However, a **KANGAROO COURT** is "a Court which acts unfairly, or dishonestly, or disregards legal rights or disregards legal procedures".
